# Recognizing and Responding to Stalking in the Workplace

## **Webinar Description: (recording available here)**

Hosted by Futures Without Violence and SPARC (the Stalking Prevention and Awareness Center), this national webinar was held on Tuesday, January 22, 2025 as part of National Stalking Awareness Month. It explored how employers, attorneys, and advocates can identify stalking behaviors, gain understanding about the impacts of stalking on survivors and on the workplace, and support workers who experience stalking in the workplace.
