State Laws Clarifying Eligibility for Unemployment Insurance Benefits for Victims of Domestic Violence, Sexual Assault, and/or Stalking

This information is for anyone providing support to survivors of domestic violence, sexual assault, and/or stalking (DVSAS). This chart contains a high-level description of state and U.S. territory employment laws This chart provides a high-level overview of the state and U.S. territory laws clarifying eligibility for unemployment insurance benefits for victims of DVSAS. Even if a state law doesn't clarify that employees who leave work because of DVSAS, they may still be found eligible and qualify for unemployment insurance benefits based on that state's unemployment insurance law.

What are Unemployment Insurance Benefits?

Unemployment Insurance benefits are a temporary partial wage replacement administered by a state agency. A qualified individual may receive unemployment insurance benefits when they quit or are fired from their job, if they are able to establish that they worked the requisite amount of time and are able and available to work a new job. Typically, applications are done online or over the phone. This state agency will review their application, determine their eligibility, and issue temporary wage replacement if the individual is deemed to be eligible and qualified. Importantly, an individual may only begin to obtain unemployment insurance benefits from the date they apply, not from the date they were

fired from or quit their job. This means that the sooner a person applies for unemployment benefits, the sooner they can access these benefits.
